
His cries for help had Timothy scowling. "Damn, you're so useless. You made me wait for nothing!"

The following morning, Liam and Julie went to Kingland Group together.


Inside the CEO's office, they engaged in a conversation about their future plans.

Fuller said softly, "We can't simply stand by while Kingland Group flourishes. We need to do something about it."




